### **Gov. DeWine Press Conference**

Today, Gov. DeWine held another press conference regarding the novel coronavirus (COVID-19). Ohio now has 50 confirmed cases in 12 counties.

Gov. DeWine and Secretary of State LaRose announced that they will request the primary election scheduled for March 17<sup>th</sup> to be delayed until June 2<sup>nd</sup>. The change will be accomplished through a lawsuit filed in Franklin County. If the delay occurs as expected, any individual who has not voted can request an absentee ballot by mail and return it by mail in the interim. No in-person voting will occur until June 2<sup>nd</sup>.

### **Chief Justice O'Connor Letter**

Ohio Supreme Court Justice Maureen O'Connor sent [this letter](#) to Ohio's judges on Friday. Courts have been advised that they must remain open but have the latitude to adjust their dockets in a way that reduces the number of people that need to come to the courthouse. Commissioners will have to work with their courts to appropriately meet needs regarding building access and security.
